1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. 7.  - Faults arising during normal usage under recommended operating conditions
- The supplier shall provide a minimum standard warranty for the period mentioned in the contract from the date of delivery.
